With this letter, the United States transmits its vote to instruct the CAFTA-DR Secretariat for Environmental Matters to prepare a factual record for the public submission: Laguna del Tigre-FONPETROL (CAALA/10/006).

We recognize that, according to CAFTA-DR Environment Chapter, the Secretariat shall proceed no further if the precise matter at issue is the subject of a pending judicial or administrative proceeding, and the government response states there are pending legal processes. We understand that, after analyzing the response and additional information presented by the Party, the Secretariat determined it did not receive sufficient documentation necessary to "validate the circumstances as they pertain to CAFTA-DR Article 17.7.5 and Section 11.4 of the Work[ing] Procedures." CAFTA-DR 17.8.3 states, "The preparation of a factual record by the secretariat pursuant to this Article shall be without prejudice to any further steps that may be taken with respect to any submission."

The United States therefore transmits this vote to instruct the Secretariat to prepare a factual record with the understanding that, if the Secretariat receives information that confirms that the precise matter at issue is the subject of a pending judicial or administrative proceeding, the Secretariat shall proceed no further.
